FOLKESTONE AIR DISPLAY

(TRAFFIC RESTRICTIONS)

TEMPORARY ORDER 2021

In the interests of public and road safety during Folkestone Air Display, Kent County Council has made an Order to temporarily restrict traffic on various roads in Folkestone.

Restrictions include closures of roads near the event itself together with parking restrictions elsewhere, to ensure smooth traffic flows and minimise disruption.

The use of the following roads will be prohibited, to the extent defined.

SATURDAY 7 AUGUST 2021

THE LEAS – between the junctions with Langhorne Gardens and Clifton Road

This closure applies from Saturday 7 August 2021 at 20:00 hours continuing through to Sunday 8 August at 21:00 hours

SUNDAY 8 AUGUST 2021

The following roads will be closed for their entire length, except where otherwise stated.

The following roads will be closed from 08:00 hours through to 21:00 hours

- **The Leas – from the junction with West Terrace to the junction with Clifton Road**
- **West Terrace**
- **Longford Terrace**
- **Longford Way**
- **Cheriton Place – between the junctions with Sandgate Road and The Leas**

- **Pleydell Gardens – in both directions**
- **Shakespeare Terrace**
- **Langhorne Gardens**
- **Clifton Gardens**
- **Clifton Crescent**
- **Clifton Road**
- **Trinity Crescent**
- **The Leas - from the junction with Earls Avenue to the junction with Metropole Road East**
- **Metropole Road East**
- **Metropole Road West**

The following roads on and near the harbour area will be closed from 11:00 hours through to 21:00 hours

- **Road of Remembrance**
- **Radnor Street**
- **The Stade**
- **Beach Street**
- **Fishmarket**
- **Back Street**

Personnel will be on site to allow managed access for residents and businesses when it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

Waiting and loading & unloading will be prohibited at any time on the roads defined below.

This applies from Saturday 7 August 2021 at 20:00 hours continuing through to Sunday 8 August at 18:00 hours

- **A260 THE TRAM ROAD – on both sides for its entire length**
- **RADNOR PARK WEST – on both sides, between the junctions with A2034 Cheriton Road and Wilton Road**
- **WEAR BAY ROAD**
 - **On the northern side, between the junction with Wear Bay Crescent and East Cliff Pavilion**
 - **On both sides, from East Cliff Pavilion to the junction with Swiss Way**
- **COOLINGE LANE – on both sides between the entrance to Folkestone School for Girls and the junction with Bathurst Road**
- **THE LEAS - on both sides for its entire length**
- **LANGHORNE GARDENS / CLIFTON GARDENS – on both sides and including the spaces in the centre of the road**

All parking restrictions will be clearly indicated by No Waiting cones and relevant signage displayed on site.

This Order over-rides all existing parking entitlements and restrictions that apply to the sections of roads defined above.

The above restrictions do not apply to

- a) Personnel and vehicles involved in the organisation and running of the event.**
- b) Anything done with the permission of or at the direction of a police officer in uniform.**
- c) Emergency access for the police, fire & rescue, ambulance service or coastguard**
- c) Access for organisations dealing with the loss of supplies of gas, electricity, water or electronic communications to premises in the area.**

This Order comes into force from 7 August 2021, remains in force throughout the event and ceases to be valid once the event is fully completed and it is safe to remove restrictions.
