Road Traffic Regulation Act 1984

The KENT COUNTY COUNCIL, acting as the Local Authority and in exercise of its powers under Sections and 1, 2, 3, 4, 5, 19, 32, 35, 36, 44, 45, 46, 47, 49, 53, 124 Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, ('the Act') the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following order:-

The effect of the named Order will be to reduce the current Permit holders only parking bay on the following length of road in Folkestone, Folkestone and Hythe:-

THE TRAM ROAD – On its south east side from a point opposite the southern boundary of Southview reduce the parking bay by 4.3 metres in a south westerly direction.

The Order was made on 30 October 2025 and its provisions will come into effect on 31 October 2025.

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement to the Orders.

- This Order shall come into operation on 31st day October 2025 and may be cited as "The Kent County Council (Various Roads, Folkestone and Hythe) (Waiting Restrictions and Street Parking Places) (Consolidation) Order (Amendment No.4) Order 2025" ('this Order').
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Folkestone and Hythe) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2025" ('the Order of 2025') shall have effect as though:
