1.0 INTRODUCTION

At the meeting of Full Council on the 19th March 2019 it was resolved at minute 1577 that the Town Clerk investigate the costs involved in extending CCTV coverage to include Cheriton High Street due to the increase in anti-social behaviour and break ins to shops etc.

2.0 PROPOSAL

It is proposed that the following would be required to provide a scheme covering Cheriton main shopping area and the indicative upfront price is £12000.

Museum Report

SUMMARY:

Folkestone Museum has been hosting many events, exhibitions, and community engagement opportunities since opening in May 2017. The intent of this report is to summarise the progress between January and March 2019.

REASONS FOR RECOMMENDATION:

The Town Council committed to sourcing funding from the Heritage Lottery to deliver its objective to preserve and enhance the town's heritage. There is a need to show evidence of working with the community and stakeholders as part of the programming agreed by the Council and the Heritage Lottery.

RECOMMENDATIONS:

1. To receive and note report CS/19/247

Aims and Objectives – Maintaining an accredited museum Financial Implications – Meeting the requirements of HLF & Council within budget Equal Opportunities – Access to all

1. Introduction:

The intent of this report is to summarise the progress of the museum during Q4 2018-19.

2. Conservation and Collection's Care

- 2.1 The audit of the collection inventory is still progressing. Almost every object has been photographed and the contents of boxes and shelves are being compared with old audits to ensure accuracy. Objects for possible display are being noted with the intention of reassessment for conservation needs in the future.
- 2.2 The archaeology collection has been photographed and is in the preliminary stages of reconciliation with digital archives which are still to be fully collated. It is the intention that the Roman and Archaeology cases will be expanded in coming months and objects from our own collection have already been selected. We are awaiting objects for possible display from Canterbury Archaeological Trust and are in talks with Canterbury Archaeological Trust and Dover Museum to ensure any additional interpretation and displays for the Roman and Archaeology cases will include more current excavations and finds.
- 2.3 The archival information relating to the museum is in the final phases of digitisation. A decision will have to be made as to how the material will be catalogued for future use either by date or by object. This material will help us flush out more about Folkestone Museums story, history of donations and the people in the Museum and the donors.
- 2.4 The collections officer is in talks with the Natural History Museum to explore the study of remains of their sample of Dover Hill skeletons which have not been studied in recent history in order to further the story of the 'Finding Aefre' project.
- 2.5 The collections officer is in talks with a lecturer at the Royal Holloway University, London to facilitate research this summer of Pleistocene mammals from the fossil collection.
- 2.6 The collections office has been in talks with a small number of 'treasure' finds that fall within our jurisdiction.
- 2.7 All donations, conservation, and storage management are kept to Spectrum standards.
- 2.8 The collections office has completed the winter deep clean and all objects within the cases remain in good order.

3. Outreach and Education

3.1 The education and outreach officer has also been hard at work building school session based around the themes of the museum. So far, she has delivered workshops about Smuggling and Pirates, Fossils and Dinosaurs, Anglo-Saxons and Roman Life and Architecture. Between January and March, a total of 1221 children and adults have engaged with our activity programme.

4. Events and Exhibitions to Date

- 4.1 In January, the museum in partnership with Shepway Sports Trust, presented a special symposium exploring the legacy of Folkestone-born Walter Tull.
- 4.2 The current exhibition 'A retrospective' by Shane Record welcomed over 130 people to its launch and several school guided tours by Record himself are scheduled. The museum hosted Seaside themed crafts and activities over the February half term and have more activities planned for the Easter holidays.

5. Upcoming Exhibitions

- 5.1 It is planned to host a Gaswork Site exhibition during June and July.
- 5.2 Talks are underway around hosting a WW1 Baseball exhibition in June to tie in with a re-enactment game at the Three Hills cricket ground.
- 5.3 Talks are also underway around hosting a Puppet exhibition at the end of July to tie in with Charivari.
- 5.4 Talks are also underway around the development of a museum-led exhibition in autumn 2019 to tie in with Eurotunnel's 25th anniversary.
- 5.5 Planning has already begun on exhibitions for 2020, and work is currently on the horizon to collaborate with the Royal College of Physicians for an exhibition on William Harvey.

6. Accreditation

6.1 Following receipt of Accreditation by the Arts Council last November, Kent County Council formally gifted the collection to Folkestone Town Council on the 27th February 2019 and a small reception was held by the Mayor with Councillor Mike Hill on the 22nd March.

7. Friends of Folkestone Museum

7.1 The friends have set up a quarterly newsletter and the Marketing & Communications Officer is working with them to add a page to the museum website to encourage new members and to advertise events and activities.

SUBJECT: Armed Forces Day 2019 - Community Fun Day Update

SUMMARY: This report outlines plans for Folkestone Town Councils Annual Armed Forces Day Event with Air Display on The Leas.

REASONS FOR RECOMMENDATION:

The Council is asked to agree the recommendations set out below because:

- 1. The Armed Forces Day event is a free fun day for the townspeople to enjoy whilst supporting the continuation to unite the Service Personnel of the past, present and future with the local community and Cadet Organisations. It further raises awareness of the Armed Forces contribution to the community ensuring Service Personnel are reminded and understand how much they are valued, respected and supported both locally and nationally.
- 2. The event and associated Air Display support the Councils commitment to the Armed Forces Covenant and its responsibility to give recognition to Service Personnel, Veterans and Cadets past, present and future.
- 3. To revitalise our town of Folkestone, restore and develop civic pride, regenerate and enhance community spirit and support local military charities, businesses and organisations.

RECOMMENDATIONS:

- 1) To receive report CS/19/248 and note the proposed event programme.
- 2) Approve the release of £3,800 from 2019 Armed Forces Day Budget & £10,000 Air Display Budget for the event.

Aims and Objectives —To make available to the community as many leisure, sport and cultural opportunities as possible and to support and enhance facilities in Folkestone. Financial Implications — circa £50,000 supported by Armed Forces Day budget, Air Display budget, New Services Reserve, external funding and sponsorship Equal Opportunities — Access to all

1. INTRODUCTION

- 1.1 The Council are organising its 11th Armed Forces Day event and air display at The Leas on Sunday 30th June 2019 in consultation with Chris Yates from AMP and with financial support being provided by Folkestone & Hythe District Council.
- 1.2 Following on from last year's successful event and comprehensive entertainment programme including Corps of The Royal Engineers Military Band in the performance arena being very well attended, extremely popular and positively received by local residents, the Council aims to provide another first-class free community event with a full and varied programme of activities and attractions.
- **1.3** The objectives include, but are not limited to:
 - Promoting social and physical wellbeing within Folkestone.
 - Forging links between a diverse range of local community groups and organisations such as schools, churches and youth groups
 - Publicise the range of support available to the Armed Forces Community
 - Profile the support of Service Personnel and Veterans to the local community and vis a versa
 - Protecting, promoting and representing the interests of local residents.
 - Organising events that are fun for all the community.
 - Engaging with the local community and encouraging civic pride.

2. CURRENT PROVISION

2.1 2019 will be the 11th year of Council organising such events.

3. THE PROJECT

- 3.1 The Communities & Events Officer together with the Town Clerk in partnership with Cadet Units and local military charities lead on organising the event programme encouraging and inviting local businesses, schools, churches, youth groups and other organisations to be participate ensuring a well promoted, attended and highly successful event is delivered.
- 3.2 The Leas Cliff Bandstand with Arena Performance area will again provide the main entertainment programme venue.
- 3.3 Entertainment will include the confirmed Air Display by the Red Arrows, military bands, performances from local schools, Cadet Unit Tug 'O' War competition, Funfair, street entertainment, Military Parade, Dance Performances and fun for families and all.
- **3.4** Folkestone Town Council are responsible for the Event Management, Safety Plan, Traffic Management and Crowd Control.

4. FUNDING / COSTS

4.1 At its meeting on 13th December 2018 the Finance & General Purposes Committee resolved that £10,000 should be made available as a contribution to the Red Arrows to be taken from the 2019/20 New Services Reserve.

In order to host these events again this year, it is recommended that the Council release £10,000 from the Air Display budget and £3,800 from Armed Forces Day budget.

At its cabinet meeting on 13th March, Folkestone & Hythe District Council resolved to financially support Folkestone Town Council with £22,000 for the event and to fund external support from AMP to co-ordinate the aerial elements.

It has subsequently been agreed that FHDC will provide £20,000 to FTC and £5,000 to AMP utilising £2,000 from the original £22,000.

Further to FTC making grant applications, £9,800 has been awarded by the Big Lottery Fund and £5,000 from the MOD to support the event.

Additional external funding and sponsorship is being sought to support delivery.

REASONS FOR RECOMMENDATION:

Aims and Objectives –To make available to the community as many leisure, sport and cultural opportunities as possible and to support and enhance facilities in Folkestone.

Financial Implications – *circa £51,000 supported by Christmas Lighting Budget* Equal Opportunities – *Access to all*

1. INTRODUCTION

- **1.1** The current lighting schemes, particularly in Folkestone Town Centre were significantly updated in 2018.
- **1.2** The objectives included, but not limited to:
 - · Promoting social and physical wellbeing within Folkestone.
 - Protecting, promoting and representing the interests of local residents.
 - Engaging with the local community and encouraging civic pride.

2. CURRENT PROVISION

2.1 2019 will be the 7th year of Council's responsibility for the Towns Christmas Lighting schemes.

3. FUNDING / COSTS

3.1 The current budget for Christmas Lighting infrastructure is £51,000.

4. CHRISTMAS LIGHTING REVIEW PROCESS

Now that the service agreement has expired Council needs to determine how it wishes to proceed with the current installed lighting scheme.

4.1 **OPTION 1**

Maintain the status quo. The costs for 2019 utilising the existing stock (summary and exact costings to be presented at the meeting) are:

2019 Installation, Takedown, Anchor bolt testing, servicing/repairs and Storage circa. £35,000

* Excludes repairs to infrastructure, lights, columns and obsolete trees.

4.2 OPTION 2

Review the entire lighting scheme - consider and determine additional sites for installation.

Assessors will visit between mid-June to mid -July and spend an hour or so to identify the work of the Parish under the assessment criteria. The aim of the category is to see what is being achieved and for Parishes to consider getting involved in the wider Britain in Bloom movement along with 1,000's of other communities UK wide.
