SUMMARY:

Folkestone Museum has been hosting many events, exhibitions, and community engagement opportunities since opening in May 2017. The intent of this report is to summarise the progress during Q2 2019-20 against the adopted forward plan and highlight the plans for delivering the remaining objectives for the HLF HEART Project by March 2020.

REASONS FOR RECOMMENDATION:

The Town Council committed to sourcing funding from the Heritage Lottery to deliver its objective to preserve and enhance the town's heritage. There is a need to show evidence of working with the community and stakeholders as part of the programming agreed by the Council and the Heritage Lottery.

RECOMMENDATIONS:

1. To receive and note report CS/19/254

Aims and Objectives – Maintaining an accredited museum Financial Implications – Meeting the requirements of HLF & Council within budget Equal Opportunities – Access to all

1. Objective: Partnership Working & Current Audience

- 1.1 In May, the museum welcomed 6 school groups from Boulogne and hosted a workshop for the Beacon School, this workshop focused on fossils and object handling. In addition, we hosted an exhibition by local artist, Shane Record. Shane offered guided tours of his work for local primary school. The Audience Development and Outreach Officer also led on 2 Roman Architecture and 1 Anglo Saxon workshops. In the half term we held bugs and butterfly craft afternoons. 535 visitors engaged in activities.
- 1.2 In June, we ran more bugs and butterfly workshops and hosted a Year 8 German class, they looked at Fossils and Romans. 176 visitors engaged in activities.
- 1.3 The summer holidays activity programme was themed each week.

The 1st week focused on Art, during this week we had a mindfulness colouring session which was aimed at SEND groups. The second activity was a workshop to make clay bugs and butterflies run by the Little Art Room.

The 2nd week was Victorian, and we hosted 3 Punch & Judy Puppet Shows, a Victorian egg decorating workshop and a postcard making workshop.

The 3rd week was Nature week, this week the museum invited the Bug Roadshow to host an activity day, the museum had 592 visitors during opening hours on this day. We also held a few family crafts during this week including a Decoupage Bunny session, Stained Glass Craft and a Butterfly Habitat workshop.

The 4th week was Archaeology Week and the museum hosted the Time Travellers and delivered in-house workshops including an Anglo-Saxon jewellery workshop and the Time Travellers hosted Pre-history and Roman workshops.

The 5th week was Dinosaur week, as well as crafts and a fossil roadshow, we hosted a performance from the outdoor theatre company rent-a-dinosaur. The company performed 5 shows and attracted 2000 visitors to the museum.

The final week of the summer holidays was Maritime Week, during this week we had a smuggler visit and pirate crafts for families.

Over July and August, the museum had **4,624** visitors participate in activities and recruited 5 new volunteers to support the busy summer holiday events programme, these volunteers are also on standby for future events in the museum.

1.4 In September, the museum will be hosting curriculum based educational workshops.

- 1.5 Our freelance curator has held consultations for a Folkestone story mat, participants included the Town Mayor, Year 6 children, members of the public from outside the museum, Folkestone MIND clients, Friends of Folkestone Museum and council officers
- 1.6 Two Halloween workshops are planned for the October half term.

2. Objective: Planned Activities

- 2.1 Folkestone Mind and Headway have put forward the idea of a future photography exhibition by their clients, either to display in the museum or on the museum's website. This would involve clients from these charities undertaking guided walks organised by the museum in which they can take photographs and then undertake research which tie into the museum's five key themes. Fashionable Folkestone and Maritime Folkestone has been identified as the two main themes that the clients would find the most interesting and relevant. It is hoped that this project can be arranged to begin in early 2020.
- 2.2 A meeting with the Nepalese community representative, in August 2019 has identified a 'living history' project collaboration between museum and the Nepalese community in Folkestone. This will take the form of digitally recording the experiences of 3 different Nepalese groups: first generation Nepalese immigrants, serving Gurkha soldiers and second generation British-Nepalese to explore how immigration and settlement in Folkestone has impacted upon Nepalese cultural attitudes and identity. The museum has audio and visual recording equipment to complete the project and a museum volunteer should be able to undertake the recording aspects of the project after training. A further meeting with the wider Nepalese community elders has been arranged for 27th September in order to further relationships and to discuss the project further. For spring/summer 2020, it has been suggested that a Nepalese 'World in a Tent' event could be held at the museum in which exhibitions of Nepalese puppetry, music, dance and story-telling are on display. This will also be discussed at the meeting on 27th.
- 2.3 Local scout & guide groups have indicated an interest in a partnership with the museum in order to assist cubs/scouts/brownies/guides to achieve their heritage badge (or equivalent).
- 2.4 Hythe Local History Museum has also indicated a desire to be involved in the partnership in respect of local Hythe scouts and guides. A meeting has been arranged with the curator of Hythe Local History Museum on 1st October to discuss this further, alongside representatives from both Folkestone & Hythe scouts/guides. It is likely that museum's input will be to develop 'a history pack' to support and tie in with the heritage badge programme requirements.

- 2.5 Subject to HLF approval it is proposed that a temporary interactive archaeological laboratory is established in the Education Room during UK Science Week, from 6th-14th March 2020. Ahead of this a range of analysis will be conducted on Anglo-Saxon remains and finds from Folkestone; the results of this work will be presented and interpreted during science week to a wide audience of all ages.
- 2.6 The preliminary analysis will include study of the reputed relics of St Eanswythe held in the nearby parish church. A faculty has been obtained to study these remains from the Church of England. This will include a full osteological study of the bones, radiocarbon dating, stable isotope analysis and, potentially, DNA. These bones of a young woman are potentially those of Eanswythe, patron saint of Folkestone and a member of the Kentish royal dynasty, who died around the middle of the 7th century AD. Potentially of international importance, they also provide a potential comparator to 'Aefre', the woman from the 6th century grave 4 at Dover Hill, Folkestone, whose skeleton forms a centrepiece to the museum's archaeological collection.
- 2.7 The faculty does not allow for the removal of the relics from the church (other than small samples for scientific testing). Therefore, this work will be carried out within the church during the latter part of 2019. The work will be fully documented, including with film and photography, with a range of specialists carrying out analysis and conservation assessment. The results obtained will then be compared to those from 'Aefre', and a range of interpretative displays (including both printed and digital outputs) will be created to present and contrast the results from these two individuals. This will be combined with analysis and interpretation of some of the finds from the Dover Hill Anglo-Saxon cemetery. A focus here will be on exotic materials within the collection, notably Sri Lankan garnets, Egyptian cowrie shells, Persian amethysts and Baltic amber. Information will be provided on the origin of these materials, including the contemporary cultural context in which they were sourced, as well as on the likely route they would have taken to reach Folkestone.
- 2.8 This work will culminate with the establishment of 'CSI:Folkestone' in the Education Room from Friday 6th to Saturday 14th of March 2020 (coinciding with UK Science Week). CSI in this context stands for 'Community Science Investigation', and the model for this is the award-winning CSI: Sittingbourne that has been run in a shopping mall in Sittingbourne by Dana Goodburn-Brown in recent years. Dana and an assistant will set up and run an interactive archaeological conservation lab during this week, which will be open to members of the public and school parties. During the week, Dana will lead work on the conservation of a range of items from the museum collections, principally items from the Dover Hill Anglo-Saxon cemetery. Members of the public will be able to view this work being carried out, and to talk with dana and her assistant about the work.

2.9 In addition, a series of visual displays, both printed and digital, will present the results of analysis on 'Aefre', the possible relics of Eanswythe, and the Dover Hill cemetery and finds, exploring themes of Anglo-Saxon women, culture and connections with the wider world. These will be supplemented by a series of talks, workshops and activities exploring what scientific analysis can tell us about human remains and material culture, and about ancient craftworking and art, plus drop-in sessions for people to bring along items they have found for identification and, if necessary, recording. These activities will be aimed at the widest possible audience, including those from minority ethnic backgrounds, who it is hoped will be inspired by the connections between Folkestone's heritage and the wider world. The aim will be to create an exhibition that can subsequently be toured around other venues in Kent (or beyond). Overall, this activity is designed to address multiple aspects of the Folkestone HEART activity plan. It will also contribute to the other activities within the Action Plan, including conservation, schools work, and enhanced interpretation in the galleries. Finally, the revealing and presentation of the results on the analysis of the possible relics of St Eanswythe should draw considerable media interest, especially if the results do suggest that the bones are indeed those of Folkestone's patron saint.

3. Objective: Outreach to Schools and Harder to Reach Groups

- 3.1 The first loan box went out to Castle Hill Primary School with an activity pack.
- 3.2 As part of the development of our offer for harder to reach audiences contact has been established with the following secondary schools in the Folkestone area: Turner Free School, Goldwyn School (SEN), Folkestone School for Girls and Harvey Grammar School. To date, there has been minimal response from the remaining secondary or SEN schools in the Folkestone area and attempts to establish contact remains ongoing. A new strategy of direct phone calls and visits will be implemented at the end of September 2019 to establish contact with these schools. A meeting with the head of history at Turner Free School in July 2019 identified the following areas in which the museum can provide direct learning support: Ancient Folkestone, Frontline Folkestone and Fashionable Folkestone.
- 3.3 During the meeting and in follow up emails it was decided that handling boxes which could be borrowed by schools would be the most appropriate method of delivering learning outcomes. An Ancient Folkestone handling box has been developed in line with the KS3 National Curriculum and is now available for loan. It includes a variety of replica artefacts (including some sensory objects) from the Roman and Saxon periods, full teacher's notes on the artefacts included and a power-point outlining the development of Folkestone between c.100 BCE and 1100 CE. A Frontline Folkestone handling box is now under development and it is estimated that this will be available for loan from October 2019.

- 3.4 A meeting has been provisionally arranged with the new history teacher at the Goldwyn School, with a view to discussing the needs and learning requirements of SEN students. Provisionally, this may include adapting or re-designing handling boxes to include a wider range of sensory and tactile items, providing extra 'scaffolding' in the form of further information and developing a range of student-focussed activities centred around key artefacts to encourage interaction and learning.
- 3.5 Since the start of the new academic year Folkestone School for Girls and Harvey Grammar School have also indicated a strong interest in handling boxes and meetings with history teachers are in the process of being organised for early October to discuss requirements.
- 3.6 So far, contact has been established with the following Special Needs and Hard to Reach Groups in Folkestone: Headway, Folkestone Mind, Age UK, the Gurkhas, KRAN (Kent Refugee Action Network), local Scouting and Guiding groups. Representatives from Folkestone Mind, Age UK, the Gurkha community and scouting all attended the recent Folkestone Museum story mat sessions and have indicated a strong interest in borrowing the mat once it is completed in February 2020. Further projects include a 'seaside memories' resource with Age UK, to be designed to encourage reminiscence and to stimulate memories of childhood.
- 3.7 Another project is to further develop a partnership programme between the museum and Living Words (a local arts and dementia charity) with Age UK. The aim is for a museum representative and a representative from Living Words to work together to go out to Age UK Centres in the area (and eventually local care homes) with a small selection of 20th century objects which can be used to promote talking in late stage dementia suffers using Living Words 'Listen Out Loud' methodology. Contact between Age UK, Folkestone Museum and Living Words has been established and discussions on this project are ongoing.

4. Objective: Informal Learning Sessions

4.1 The Friends of Folkestone Museum hosted 2 talks in May, and 2 in June, one celebrated the work of HG Wells and the other discussed Folkestone's role in the Treaty of Versailles.

5. Objective: Evaluation & Planning

5.1 The Town Clerk and the freelance curator have been assessing objectives that need to be completed by the 30th March 2020 to ensure compliance with the Heritage Lottery Fund HEART project grant terms and conditions. Attached at Appendix A is a table covering all areas that we believe need additional work to

meet the project objectives several of which are covered within this report but are subject to HLF approval.

6. Objective: Temporary Exhibitions + Associated Events

- 6.1 The Gasworks Exhibition was launched on the 27th June 2019.
- 6.2 In June, a WW1 Baseball exhibition was held to tie in with a re-enactment game at the Three Hills cricket ground.
- 6.3 At the end of July, we hosted a Puppet exhibition to tie in with Charivari.
- 6.4 The current exhibition has been developed in partnership with Eurotunnel staff since May, 'Eurotunnel 25 years' exhibition was opened by Councillor Ray Field with a private view on the 13th September. In October, the museum will see the start of 10 Eurotunnel workshops, which will run until the end of the temporary exhibition in March 2020. It is anticipated that 300 students will benefit from the sessions with the Eurotunnel training manager.

7. Objective: Staff and Volunteer Development

- 7.1 Volunteering at the museum has been identified as another key area of outreach and volunteering opportunities have been re-advertised locally over the past few weeks. So far, there has been an uptake of around six people and the next stage of promotion will be towards local charities such as Mind UK and Headway in order to engage a wider range of volunteers.
- 7.2 A possible partnership with East Kent College has been mooted as part of their enterprise and business learning programme and three East Kent College students have indicated an interest in volunteering. A volunteering plan and training package is expected to be developed for early October with the first volunteers beginning in early November 2019.
- 7.3 As part of our staff development programme, CAT will provide a series of training events for museum staff and volunteers, aimed at raising awareness and skills around archaeology. This will include a training day specifically focussed on the sites and collections from East Wear Bay (including Folkestone Roman villa) and the Dover Hill Anglo-Saxon cemetery. Other topics will include the archaeology of Folkestone, as well as archaeology and archaeological community engagement and education. These will be offered as a series of workshops that can be fitted into half-day or one day sessions.

8. Objective: Collections Access, Development and Management

8.1 The audit of the collection inventory is still progressing. Virtually every object has been photographed and the contents of boxes and shelves are being compared with old audits by the volunteers to ensure accuracy.

8.2

9. Objective: Conservation

- 9.1 To ensure the ongoing care of the collections all donations, conservation, and storage management are kept to Spectrum standards.
- 9.2 The Roman and Archaeology cases are being expanded in the coming months with objects from our own collection and objects from the Canterbury Archaeological Trust. Conservation of the archaeological collections is not explicitly outlined as a separate activity in the Action Plan, but it is highlighted elsewhere in the project deliverables and is clearly a vital outcome of the project. It is proposed, subject to HLF approval, that a day of Andrew Richardson's time will be funded to assist Dana Goodburn-Brown ACR with the assessment and selection of finds for priority conservation work.
- 9.3 On initial inspections by conservators it has been highlighted that the collection is not packed appropriately and a timetable of repackaging and agreed remedial conservation treatments is needed. Repackaging will also result in capacity for increased access to the collection and will increase awareness of the wonderful items the museum contains and the stories behind them.

10. Objective: Capital Works/Externally Funded Projects

- 10.1 There are some elements of the HLF project that need to be completed by March 2020 including the two archaeology cases in the museum (one on general archaeology, one on Roman Folkestone) both have spare capacity for additional finds and interpretation as access to objects was restricted until they were in our possession.
- 10.2 It is proposed that Canterbury Archaeological Trust take on responsibility for selecting and captioning addition finds, drawn both from the existing museum collections and by loans from archives currently held by CAT, that will be mounted in these cases. In addition, CAT will draft additional text and select images to enhance the displays in these cases.
- 10.3 Furthermore, the text on the video screen in front of the Dover Hill Anglo-Saxon cemetery case will be enhanced. In creating this enhanced interpretation, we will draw upon the analysis and research carried out for the CSI: Folkestone activity described above, with a view to stressing the international origins of much of the locally found material culture on display, with a view to widening the appeal of the displays to diverse audiences.

11. Objective: Resilience

- 11.1 The museum merchandise is currently being reviewed and new stock is being considered.
- 11.2 A museum themed colouring book is being developed as part of our health and well-being programme.
- 11.3 The museum has applied to be part of the 'Wheels of Time' membership scheme for 2020. This is a badge collecting scheme for museums in Kent that's aims to raise awareness of museums and increase visitor numbers. We have already had several enquiries from families who have visited that participate in the scheme.
- 11.4 A new permanent curator has been appointed and will be in post from the 14th October.

12. Objective: Building Management

- 12.1 The Air Conditioning System has had an annual service following the replacement of the faulty external chiller unit an issue with water flow that was picked up during the very high summer temperatures is currently being investigated.
- 12.2 The Town Clerk has checked the AV hardware, interactives and cabinetry and the Morse Code interactive and two draws have been repaired.
- 12.3 The Audience Development and Outreach Officer has commenced the annual condition check of education packs and resources to ascertain additional items required to deliver the planned activities.

SUBJECT: Allotments Charges

SUMMARY: The report reviews allotments charges for 2020/21.

REASONS FOR RECOMMENDATION:

1) The Committee is required to assess the options for allotments rents.

2) The Committee is required to recommend appropriate allotments rental charges for 2020/21.

RECOMMENDATIONS:

- 1) To receive and note report CS/19/255
- 2) To consider allotment rents for 2020/21

Aims and Objectives – FTC actively promotes allotment holding and welcomes the current large demand for allotments. If possible, we seek to find new land that is suitable to be turned into allotments to add to our sites at Tile Kiln Lane and Park Farm Road.

Financial Implications – None if the status quo is maintained.

Equal Opportunities – All tenants will be treated equally and with fairness.

1. Background

- 1.1 The Committee completed its four year allotments rental pricing strategy in 2015, at which time it conducted a ballot of allotment holders to ascertain their preferred level of service and corresponding rental charges.
- 1.2 The ballot results indicated that tenants were clearly in favour of Option D (no change to the existing level of service and for the rent to remain at £0.556p per m²).

2. Current Position

2.1 The table below shows budgeted revenue expenditure/income for the 2019/20 financial year based on a rent of £0.556p per m²:

2.2 In 2018/19, the service produced an operating surplus of approximately £190. This is an indication of the fluctuating nature of the annual expenditure on this service. As at the end of October 2019 the actual revenue costs for the allotments are within budget. It is therefore recommended that the current rental charge is retained for next year and continues to be monitored on an annual basis.

3. Rent Review

3.1 Under the Allotments Act 1950 there is no requirement to exact a full fair rent. Land let by a council for the purposes of allotment gardening shall be let at such a rent "as a tenant may reasonably be expected to pay for the land taking into account the proposed letting terms".

3.2 The Council has previously indicated that it does not wish to subsidise the allotments service from its precept. Following its four year strategy, this aim appears to have been achieved and therefore no further rent increase is recommended at this stage.

4. Recommendation

4.1 To maintain the status quo (i.e. no change to the existing level of service and for the rent to remain at £0.556p per m^2).

SUMMARY: This report is to feedback the results from the recent consultation on the proposed bus stop improvements.

REASONS FOR RECOMMENDATION:

- 1) The Committee supported the installation of bus shelters.
- 2) The Committee is required to support an annual budget for cleaning and insurance.

RECOMMENDATIONS:

- 1) To receive and note report CS/19/256
- 2) To arrange the installation of the bus shelters within the grant timeframe
- 3) To undertake a review of the bus stops highlighting shelters in need of repair or potential locations for new shelters with a view to applying for funding via the Parish Shelter Scheme in 2020/21.

Aims and Objectives – Improve the environment and protect residents from the elements.

Financial Implications – Match funding from the new services reserve and ward grants.

Equal Opportunities - Meet disability access requirements.

1. Background

1.1 Funding has been secured subject to match funding through Kent County Council's Parish Bus Stop Shelter Grant Scheme 2019-2020 to improve the following bus stops by installing shelters.

Stanley Road Bus Stop - Shaftesbury Avenue, Cheriton Kent Road Bus Stop - Shaftesbury Avenue, Cheriton Tontine St adj Old High Street stop, Folkestone

1.2 Match funding was discussed at the Finance & General Purposes 5th September 2019:

1302. MATTERS AND RESOLUTIONS FROM OTHER COMMITTEES i) Community Services Committee - 4 June 2019

Application has been made to Kent County Council, under its Parish Bus Shelter Scheme, for three shelters. Confirmation has now been received from KCC that three grants of £3,000 each have been approved subject to match funding, evidence of consultation with residents and approval of the type of shelter. The works must be completed by December. Match funding up to £9,000 will therefore be required.

The Committee was asked to consider whether it wishes to support the scheme prior to commencing the consultation process, etc.

RESOLVED: That the Committee agrees to the request with funding to be met from the New Services Reserve. The Town Clerk will write to County Councillors and Town Councillors requesting contributions from ward grants.

Proposed: Councillor P Gane Seconded: Councillor N Keen

Voting: F:8, Ag:0, Ab:0

- 1.3 £700 in ward grants has been received from Town Councillors but to date no response has been received from the County Councillors.
- 1.4 A budget of £250 per shelter is recommended for insurance and cleaning.

2. Proposed Scheme

2.1 The purpose of the scheme is to improve the quality of bus stops by installing new shelters to protect passengers from adverse weather conditions and to give the mobility impaired and parents with push chairs better access on and off the bus and somewhere to sit whilst waiting.

3. Consultation

3.1 Consultation letters were distributed to residents and businesses in the vicinity of the proposed scheme with feedback requested by the 30th September 2019 detailed at Appendix A is the feedback received to date.

John Pugh the Roadside Infrastructure Manager Stagecoach South East was also approached, he confirmed that Stagecoach would support the provision of a shelter in Tontine Street, Folkestone, at the town-bound stop adjacent to the Old High Street. This would be subject to the stop still meeting current disabled access standards and the shelter being maintained going forward either by Folkestone Town Council or Folkestone- Hythe District Council.

It may be necessary for the bus stop pole to be repositioned (it is owned by KCC Highways) and for a bollard (also owned by KCC Highways) to be removed. KCC Highways would also need to be consulted, and they may have a view concerning sight lines for traffic exiting the Old High Street.

There is a bus stop more or less opposite Marigold House, for buses going towards Cheriton and the Town-bound stop is on the corner of Salisbury Road, neither have a shelter but both stops could accommodate them if they were correctly specified and configured, and that Stagecoach, Dan Bruce KCC & Paul Thompson FHDC support the provision of shelters at these stops.

4. Forward Plan

4.1 The Town Clerk will now arrange for Kent County Council to be notified of the type of shelters proposed (including quotations for works), that match funding has been agreed and the results of the consultation including confirmation of local operator support; with a view to arranging the installation of the new shelters within the grant time frame.

Appendix A - Consultation Comments Received

Below are the comments from respondents who answered in response to the Stanley Road & Kent Road bus stop proposals

Can you give me any more information on where this bus shelter is due to be built, i.e. at the existing location of the actual bus stop? I live in Shaftesbury Avenue and the length of the bus stop area is incredibly long as it stands, so as to give limited ability for us and others to park outside our own house. The bus stop is never used by more than one vehicle at a time, you could fit two buses within the road markings. Why is it so long and why does it take up so much space? The preceding bus stop for route 71 is also far too close to the Stanley Road bus stop. It would much more sense to situate the Stanley Road stop directly outside the Folkestone Age UK property, which would help infirm users to be nearer their destination. It would also space out the two Folkestone bound stops to best cover the road for general passengers. The Stanley Road stop is crowded out by the hedge belonging to 89 Stanley Road, and people have to squeeze by on the pavement if anybody is waiting at the stop as it is. If a bus shelter is to be built there then pedestrians will have to walk into the road to get by any waiting queue. Sometimes we have to do this any way if there are quite a few people waiting for a bus. They rarely move to enable anybody to get by, including women with prams. If the plan is to move the stop along a few feet to occupy a small patch of waste ground at the crossroads then this would be another solution, and to retract the length of the bus stand road markings accordingly meaning it would slightly improve our parking opportunities.

The situation of parking is also further exacerbated by the bus drivers themselves, many of whom park all along Shaftesbury Avenue when working from the Stagecoach garage in Kent Road. I hope you find this information of interest and can I be informed of any future developments directly.

Shelters will be good, but the pavement is very narrow in the area, can the shelters be installed with the glass edge on the curb side rather than against the hedges of resident's property.


Below are the comments from respondents who answered in response to the Tontine St bus stop proposal

There's nothing included in your letter about the look or exact placing of the proposed shelter but I do have some concerns. I live in a flat above Blooms and see a lot of near miss accidents. The location has had so many different changes and has fairly frequent/excessive speeding cars, taxis, buses both ways in Tontine Street, extreme cutting of the corner (turning right from Tram Rd) and speeding in a straight line from Harbour Way into Tontine. Pedestrians are often entering that 'bus stop' area from traffic free streets and have to gather children and be alert and orderly in a short time. Some cross the road while people are still entering a bus but only looking for cars overtaking that bus, not expecting a bus, taxi or bicycle to be coming the other way. Speed camera, hump or 20 limit could save some accidents. Signing would really help that area, even just on the curb. My concerns about a new shelter are too make sure that it does not further block or distract the view of pedestrians crossing the road in any direction.

I am involved in on-going study of the area where the present bus stops are sited on Harbour Street, Folkestone. I understand there is now to be a bus shelter. I would like to express my concerns. I am a resident of the Old High Street and my office is in the car park adjacent to the bus stops, meaning I am a first hand witness of what I describe below.

1. While as a bus user, I greatly appreciate the importance of shelter for those waiting for a bus, I don't understand why there would only be one, so I assume from volume of passengers that would be on the west side of Harbour Street.

- 2. This whole area is subject to piecemeal development, with one element not related to another. The result is a chaos of furniture, signage and uncertain facilitation of pedestrian needs in general.
- 3. More particularly, if one were blind, one would not know that the drop kerbs that tell one precisely where it is safe to cross are now blocked by two bus stops.
- 3. The current, seemingly arbitrary, placing of the bus stops causes irritation to drivers freshly turned into Harbour Street but who then often have to stop again. In consequence, near misses are a regular feature of this area. What should be where the bus stops currently are is a clear pedestrian crossing super-imposed on the existing blind persons crossing area.
- 4. Can the bus stops not be better placed, therefore, further into Tontine Street and perhaps staggered?
- 5. Providing shelter for waiting passengers is understood, but those of us trying to upgrade the area from a visitor and pedestrian point of view, are also trying to increase the cafe culture in line with the town's aims of becoming a better tourist destination with this whole area as a clear candidate. A case in point is the frontage of Bloom's restaurant, currently a pleasant open space at the bottom of the Old High Street. This would be the worst place to site a bus shelter, therefore, and reason again for resiting the bus stops in Tontine street.





Cinque Ports Coastal Rowing Challenge

Introduction

The Cinque Ports Coastal Rowing Challenge is a celebration of our region's particular maritime heritage. Community groups in each of the Cinque Ports member towns will be challenged to build a rowing skiff and then to enter one or more teams into a coastal rowing match against fellow Cinque Ports members.

This project will fall into three phases:

- 1. Community Boatbuilding Project
- 2. Formation of Coastal Rowing Clubs & Annual Coastal Rowing Matches at member locations
- 3. Towards Sustainability

Celebrating our maritime heritage

The Confederation of Cinque Ports in Southeast England was originally established for military and trade purposes; it pre-dates the formation of the Royal Navy and is even mentioned in the Magna Carta.

In 1155 a Royal Charter established the ports to maintain ships ready for The Crown in case of need with each port fulfilling a proportion of the annual duty. In return the towns received the certain privileges including exemptions from taxes and import duties.

In addition to the five main ports, Hastings, New Romney, Hythe, Dover and Sandwich, the confederation includes two 'Ancient Towns', Rye and Winchelsea, and seven 'Corporate Limbs':

Lydd

Deal

Folkestone

Ramsgate

Faversham

Tenterden

Margate

For many people in our region, the last time they took to the water was for a channel ferry crossing. Sailing is often (and incorrectly) perceived as a pursuit reserved for the wealthy owners of luxury yachts and, anecdotally, seems less open to new starters. Rowing, however, has benefitted from British success in the Olympics and the advent of charity Dragon Boat racing and is perceived as more accessible to the ordinary member of the public.

This project will encourage communities to re-engage with our maritime heritage in a genuinely hands-on way, whilst simultaneously generating interest in a sporting activity that is growing in popularity across the whole of the UK.

Phase One - Community Boatbuilding

As has been demonstrated by the Faversham-based Creek Learning Project, and by the recent Boatbuilding Experience led by local craftsman, Alan Thorne, the shared activity of building a boat is an excellent way to enhance community cohesion, develop new skills, self-confidence and promote awareness of our maritime heritage.

Participants in the Creek Learning Project and the various Boatbuilding Experiences have described their participation as a tremendously positive experience that allowed them to learn new skills and understanding. It has been particularly helpful for those living with depression and anxiety, offering a calm, meditative environment in which to gently re-build links with their local community.

The community boatbuilding project would take between 16 and 26 weeks, depending upon the intensity of the programme and the availability of resources.

Phase Two – Formation of Coastal Rowing Clubs

Using seed funding from local and regional Trusts and Charitable organisations, each member town would be encouraged to form a Coastal Rowing Club (or an associated group of an existing similar club) that will introduce the local community to Coastal Rowing and providing coaching and training in the sport.

The towns would be encouraged to enter rowing teams of men, women, veterans and mixed groups as demand allowed.

Each participating town would, of course, need to identify safe storage for the rowing skiff and associated equipment.

Annual Coastal Rowing Matches

With the support of the local community, a number of coastal rowing matches would take place between the various member towns to create a Cinque Ports League.

There would also be a need for the ongoing maintenance and building of further rowing skiffs for additional teams or as replacements that would afford the local community the ongoing opportunity to be involved in boatbuilding experiences.

Phase Three - Towards Sustainability

Having established a Centre of Expertise at The Purifier, and potentially in other participating towns, services could be offered on a fee-charging basis to support the ongoing sustainability of the project, including:

- Boatbuilding Service to other rowing clubs
- Boatbuilding space/tool hire for other groups
- Boatbuilding Training Provision including formal qualifications
